INFORMATION NOTICE pursuant to Article 13 of Regulation (EU) 2016/679

Dear Member,

We wish to inform you, as Data Controllers, that Regulation EU/2016/679 – General Data Protection Regulation (G.D.P.R.), which is directly applicable in Italy pending the issuance of the Decree provided for by Community Law no. 163/2017, establishes the protection of individuals and other subjects with regard to the processing of personal data.

According to this regulation, data processing will be carried out in accordance with the principles of fairness, lawfulness, and transparency, and with respect for your privacy and rights.

In accordance with Article 13 of the G.D.P.R., we provide the following information:

1a) The personal data (such as personal details and contact information) you provide will be processed for the following purposes based on your consent and on the legitimate interest of the undersigned sports association (a.s.d.): inclusion in the register of members and related registration with the Centro Sportivo Educativo Nazionale (National Educational Sports Center) through the affiliated regional committee, and any other uses related to said membership and sports registration. Data will also be collected for communication to the Italian National Olympic Committee (CONI) for the management of the Register of Sports Associations to fulfill institutional obligations.

1b) Furthermore, with specific consent, the data may be used for communications promoting and disseminating sports by the Italian National Olympic Committee.

2. The legal basis for this processing is found in Article 36 of the Italian Civil Code, fiscal regulations for non-commercial entities (particularly Article 148 of the Unified Income Tax Law), Article 4 of Presidential Decree 633/72, and Article 90 of Law 289/2002, as well as CONI and federation rules regarding registration and participation in activities organized or co-organized by these bodies.

3. The legitimate interests pursued by the Data Controller include the correct and transparent application of the association's internal regulations, the possibility of benefiting from tax advantages applicable to the association, and the ability to participate in activities organized by the mentioned entities.

4. Processing will be carried out using manual records, possibly supported by electronic means, stored in secure places accessible only to the President and administrative officers, or electronically on a computer located at the association's headquarters equipped with appropriate IT security measures (firewall, antivirus, regular backups). Access is restricted to the President and authorized administrative staff. In accordance with Article 4(2) of the G.D.P.R., data processing may include collection, recording, organization, consultation, processing, modification, selection, extraction, comparison, usage, interconnection, blocking, communication, deletion, and destruction of data.

5. Personal data will be retained for the period necessary to maintain an accurate members register and to fulfill the requirements of the affiliated National Educational Sports Center. This period is defined by the Civil Code, tax legislation, and CONI/Centro Sportivo regulations.

6. Providing your data is mandatory to fulfill the purposes of the Association's Statute and is therefore necessary to accept your membership application and/or register with the relevant entities mentioned above. Refusal to provide such data will prevent your membership and/or registration, making it impossible to establish the relationship with the National Educational Sports Center and CONI.

7. Personal data may be disclosed to the affiliated National Educational Sports Center and its regional branches. The data will not be disclosed to other third parties nor will it be publicly disseminated.

8. Processing will not involve so-called "sensitive" data, i.e., data revealing racial or ethnic origin, religious or philosophical beliefs, political opinions, trade union membership, health status, or sexual life. If medical data is mandatory for legal or insurance purposes, it will be handled and stored directly by the association's medical officer.

You have the right at any time to access your data, know its origin, verify its accuracy and completeness, request its update or correction, receive it in a structured and machine-readable format, withdraw consent, and object to processing, in accordance with Articles 15–20 of the G.D.P.R. You may exercise these rights by sending a written request to the address listed in point 9, or via certified email to altogardakite@pec.it.

12. You may revoke your consent at any time without affecting the lawfulness of the processing carried out before the revocation. This can be done by sending a withdrawal notice to the addresses listed in points 9 or 10.

13. You have the right to lodge a complaint with the Data Protection Authority or any other supervisory authority that may be established under the Community Law no. 163/2017.

14. No automated decision-making or profiling, as described in Article 22(1) and (4) of the G.D.P.R., is carried out.
